The High Court of Andhra Pradesh issued notification vide Roc No.595/2024-RC on 23.07.2024 calling for applications for appointment of twelve (12) Law Clerks on contract basis to assist the Hon'ble Judges. In response to the said notification, the High Court received 336 applications. On scrutiny, it is found that, only 130 applicants meet the eligibility criteria as per the terms of the notification. The applications which are found to be on correct lines, are shown in Annexure –I. So far as the other applicants are concerned, they do not fit the criteria as mentioned in the guidelines published along with the notification. Therefore their applications have been rejected Vide Annexure-II.

The applicants who found to be eligible for Viva Voce, are shown in Annexure – I, are directed to appear for Viva Voce on 09.09.2024 to 12.09.2024 as per the schedule. The applicants appearing for Viva Voce are directed to approach the Recruitment Cell, High Court of Andhra Pradesh at Amaravati, Nelapadu, Guntur District -522239 at 2.00 PM on respective date for verifications of documents, followed by Viva Voce.

No separate call letters will be sent to the applicants. The downloaded copy of this notification, is sufficient, to appear for the Viva Voce. No T.A. and DA will be paid.
