- With interest in conducting training programs for Advocates and Advocate Clerks.



They will be one point contact for all the advocates and who will in turn conduct awareness programs for Advocates and Advocate clerk in their regional language. The date, time, and schedule of the intensive training will be intimated in due course.

Hence, the consolidated list of the potential Master Trainers among advocates may be forwarded to the e-Committee in the prescribed format enclosed herewith on or before 14.08.2020.


