2. List of provisionally selected candidates for non-technical posts and list of eligible candidates for skill test placed on the official web site of High Court of Andhra Pradesh vide Notification No. 19/22-RC, dated 29.03.2023.

The High Court issued notifications on 21.10.2022 for Recruitment to vacant posts in District Judiciary of Andhra Pradesh. Computer Based Examination were conducted from 21.12.2022 to 02.01.2023. The list of selected candidates excluding the candidates who come under Meritorious Sports Person category, for the Technical and Non-technical posts were published on Official Website of High Court of Andhra Pradesh on 29.03.2023.

So far as, the candidates who come under Meritorious Sports Person category concern the High Court of Andhra Pradesh after considering the eligible criteria short listed the candidates. **"The Meritorious Sports Person list which is being published is only eligible candidates list for consideration under the category. The list is not a selection list."** All the candidates whose names and hall ticket numbers are shown in the eligibility list are directed to approach the District Court between **07.08.2023 to 14.08.2023** for submission of their documents viz., education qualification documents as well as the documents under which the candidates claimed reservation of Meritorious Sports Person.

The candidates shall furnish attested copies of all the documents and shall also produce the Original Documents for perusal of the District Court Officials. The District Court Officials after comparing the Original Documents with the attested copies of documents, would return the Original Documents to the candidates. The District Officials after 14.08.2023 would compile all the documents, list it out in a tabular form and send all the attested copies of the documents to the Registrar (Recruitment) on or before 19.08.2023 to proceed further.

There is possibility that the candidates shown in this list had already been selected under Open Category either in List-1 or in List-2. Such Candidate need not appear for submission of documents. All the candidates who have crossed 32 marks, 28 marks and 24 marks out of 80 marks are shown in the list.

Irrespective of the marks secured by the candidates, posts under the Meritorious Sports Person category are earmarked to the candidates who excelled in their chosen sport. Only such of those candidates who competed in the highest category of sport and in highest level of competition will be considered for the posts as per the G.O.Ms. No.74, Youth Advancement, Tourism and Culture (Sports) Department dated 09.08.2012.

The candidates who come under the Meritorious Sports Person are not allowed to produce any document which is contrary to the documents uploaded by them along with application.
