



**Notification No.13 /2022-Estt., dated 21.10.2022**

The High Court of Andhra Pradesh issued Notification No.13/2022 on 21.10.2022 inviting applications from the candidates and conducted computer based objective type examination on 20-01-2023 for filling-up 135 posts of Office Subordinates in the High Court.

The list of 133 candidates ~~are~~ provisionally selected to the post of Office Subordinates ~~are~~ placed on the official website of the High Court on 23-02-2023. The remaining two posts are pending for verification of certificates under sports category.

The list of 51 candidates of Meritorious Sports Persons, who qualified in the Computer Based objective Type Examination conducted on 20-01-2023, was placed on the official website of the High Court directing them to appear before the High Court of Andhra Pradesh, Amaravati **on 29-04-2023 at 10:00 a.m.** for verification of original certificates containing Educational Qualifications, Original Transfer Certificate, Caste and concessions claimed by them under Non-Creamy Layer, Economically Weaker Sections, Ex-Servicemen, Physical Disabilities and Sports etc. and to submit **Form-1/ Form-2/ Form-3/ Form-4**, as per G.O.Ms.No.74, dated 09-08-2012. Accordingly, 11 candidates ~~were~~ appeared for verification of Original certificates. Out of 11 candidates 8 candidates have submitted **Form-1/ Form-2/ Form-3/ Form-4** and the said Forms forwarded to the Sports Authority of Andhra Pradesh for issuance of eligibility certificate for appointment under Sports quota to the post of Office Subordinate.

The Sports Authority of Andhra Pradesh has sent a Tentative Priority List of the 8 candidates to the High Court of Andhra Pradesh for consideration under Sports quota to the post of Office Subordinate. The list enclosed as **Annexure-A**.

The candidates may submit objections, if any, on the Tentative Priority List with supporting documents, to the Registrar (Administration), High Court of Andhra Pradesh, Amaravati on or before 21-11-2023


