Junior Civil Judge (Juvenile Court), Srikakulam, VICE Smt. Nageedi Sree Lakshmi, transferred.
2. On relief, Smt. Nageedi Sree Lakshmi, I Addl. Junior Civil Judge, (Juvenile Court), Srikakulam, is transferred and posted as Prl. Junior Civil Judge, Srikakulam (post kept vacant).
  - i) Ms. Kandikatla Rani will proceed to her station and shall take charge of her post from Smt. Nageedi Sree Lakshmi.
  - ii) Smt. Nageedi Sree Lakshmi, on relief by her successor, shall take charge of her post from Judicial Magistrate of First Class, Special Mobile Court, Srikakulam.
  - iii) Ms. Kandikatla Rani is directed to submit Medical Fitness Certificate obtained from a Doctor not below the rank of Civil Surgeon and submit the same to the Prl. District and Sessions Judge. In turn, the Prl. District and Sessions Judge shall forward the same to the High Court of Andhra Pradesh.

**ORDER:**

The Hon'ble High Court of Andhra Pradesh, issued a notification on 28-02-2017 for 23 vacancies in the cadre of Civil Judge (Junior Division), apportioning (19) under direct recruitment and (4) under recruitment by transfer. The erstwhile Hon'ble High Court of Judicature at Hyderabad for the State of Telangana and the State of Andhra Pradesh declared the provisional list of selected candidates on 04.04.2018 for 20 out of 23 notified posts of Civil judge (Junior Division) in the State Judicial Service by direct recruitment and recruitment by transfer, wherein Ms.Kandikatla Rani, who applied for the post, was not in the provisional selection list declared by the High Court. As per the recommendations of Hon'ble High Court, Government have issued orders appointing (15) candidates as Junior Civil Judges vide reference 1<sup>st</sup> read above.

2. Ms.Kandikatla Rani filed Writ Petition No.21445 of 2018 for revaluation of the answer of Part-A Q.No.1(a). The Hon'ble High Court in its order dated 18-09-2019 directed the Registry to award five marks to the petitioner for question No.1 (a) of Part-A (Civil) and to consider the case of the petitioner for appointment to the post of Civil Judge (Junior Division) subject to fulfillment of all the mandatory requirements of Law.

3. In the reference 2<sup>nd</sup> read above, Ms.Kandikatla Rani, Advocate has requested the Government to consider her appointment to the post of Junior Civil Judge, based on the High Court Order and as confirmed by the Hon'ble Supreme Court of India in SLP(Civil)No.28918 of 2019, dated 18.12.2019.

4. In the reference 3<sup>rd</sup> read above, the Registrar (Recruitment), High Court of Andhra Pradesh, has requested the Government to consider the order dt:18.09.2019 passed by the High Court of Andhra Pradesh in Writ Petition No.21445 of 2018 and as confirmed by the Hon'ble Supreme Court of India in SLP (Civil) No.28918 of 2019, dated 18.12.2019 for appointment of Ms.Kandikatla Rani (H.T.No.17044), to the post of Civil Judge (Junior Division) by placing at appropriate place in the seniority as per merit without any monetary benefits, as per the decision taken by the Registry.

5. In the Andhra Pradesh State Judicial Service Rules, 2007, the post of Junior Civil Judge is defined as Civil Judge in Rule 3 (iii).

6. Accordingly, Government hereby direct that Ms.Kandikatla Rani, shall undergo the prescribed period of training after executing bonds on her appointment as per rule 8 of the Andhra Pradesh State Judicial Service Rules, 2007. On completion of the prescribed training, she shall be appointed temporarily as Junior Civil Judge. The appointment of the said candidate as Junior Civil Judge and her deputation to undergo prescribed training shall be subject to the production of Physical fitness certificate by her to the Hon'ble High Court of Andhra Pradesh. The Character and antecedents of the candidate has been got verified by the Additional Director General of Police, Intelligence, Andhra Pradesh, Vijayawada.
