**RECRUITMENT FOR THE POST OF COURT MASTER AND PERSONAL SECRETARY TO THE HON'BLE JUDGES AND REGISTRARS**

The High Court of Andhra Pradesh issued Notification No.4/2022 on 28.09.2022 and issued corrigendum on 17.10.2022, conducted examination on 19.11.2022 and interview on 25.11.2022 for recruitment to 86 posts of Court Masters and Personal Secretaries to the Hon'ble Judges and Registrars.
