SUB: RECRUITMENT TO THE POSTS UNDER MERITORIOUS SPORTS PERSONS CATEGORY - Notification Nos.4/2025-RC, 5/2025-RC, 9/2025-RC and 10/2025-RC dated 06.05.2025 for recruitment to the posts of Field Assistant, Examiner, Process Server and Office Subordinate in District Judiciary.

The Notification Nos.4/2025-RC, 5/2025-RC, 9/2025-RC and 10/2025-RC dated 06.05.2025 for recruitment to the posts of Field Assistant, Examiner, Process Server and Office Subordinate in District Judiciary issued, and computer based examinations were conducted from 20.08.2025 to 24.08.2025. The lists of selected candidates excluding the candidates who come under Meritorious Sports Person category, for the Non-technical posts were published on 26.12.2025, 31.12.2025 and 07.01.2026.

The lists of eligible candidates under Meritorious Sports Persons category for the post of Field Assistant, Examiner, Process Server and Office Subordinate are appended herewith.

So far as, the candidates under Meritorious Sports Person category is concerned, the High Court of Andhra Pradesh after considering the eligible criteria under each category short listed the candidates. **"Thus Meritorious Sports Person list which is being published is only eligible candidates list for consideration under the category. The list is not a selection list."** All the eligible candidates under Meritorious Sports Persons category for the posts of Field Assistant, Examiner,

Process Server and Office Subordinate are informed to approach the **PRINCIPAL DISTRICT JUDGE COURTS** of the respective Districts (the Districts in which the candidate wish to be appointed) and to furnish relevant documents in Form-I, Form-II, Form-III & Form-IV of G.O.Ms.No.74, Youth Advancement, Tourism and Culture (Sports) Department, dated 09.08.2012 (whichever is applicable to the candidates), educational qualification and community certificate, as per the schedule given below:

There is a possibility that the candidates shown in this list have already been provisionally selected other than Meritorious Sports category. Such candidates need not appear for submission of documents for the same post if he has already been selected. The eligible marks for OC/EWS is 32, BCs is 28 and SCs/STs 24 is marks.

Irrespective of the marks secured by the candidates, posts under the Meritorious Sports Person category are earmarked to the candidates who excelled in their chosen sport. Only those candidates who competed in the highest category of sport and in highest level of competition will be considered for the posts as per the G.O.Ms.No.74, Youth Advancement, Tourism and Culture (Sports) Department, dated 09.08.2012.
