WELCOME TO ANDHRA PRADESH

Andhra Pradesh extends a warm welcome to you. The land, replete with history and legend and endowed with an equable climate and hospitable people, invites you. A land of the mighty Krishna and Godavari rivers, with a rich cultural heritage of literature, art, music dance and drama, it abounds in magnificent monuments which breathe history, lakes and beaches which exude charm and beauty, wild life sanctuaries that bring to your eye the majestic animal kingdom, great ancient, temples, mosques and churches, and modern temples.

AMARAVATI : It is famous for its elegant architectural and sculptural remains of Buddhist origin. The stupa is the largest in the country measuring 36.5 meters wide and 16.5 meters high. Lord Amareswara's temple here draws thousands of pilgrims on Sivaratri day.

AHOBILAM : Ahobilam, an ancient temple is dedicated to Lord Vishnu who took Narasimha Avatara in order to kill the demon Hiranyakasipu. The place is also called Singavel Kunram. There are a number of places in which Narasimhavatara or Lord Vishnu is worshipped, but it is only at Ahobilam that all the nine forms of the Lord Narasimha, Nava Narasimha are worshipped.

As soon as the foot of the hills is reached, there is the temple of Prahladarada Narasimha, i.e. the aspect of Lord Narasimha as blessing Prahlada. From the foot of the hill one has to ascend the hill to reach what is called Upper Ahobilam. The Upper Ahobilam is a plateau, 853.44 metres above sea level. The two crests of the hill are called vedadri and Garudadri, through which the sacred Bhavanasini Tirtham flows inside part of its course. On southern slope of the hill, the Lord in his fierce aspect called Ugra Narasimha is worshipped. The temple is magnificent with a mantapa and gopuram. Nearby is the shrine of Guha Narasimha at the entrance of which is a huge pillar. The popular belief is that in the famous Puranic story of Prahlada, the pillar which Hiranyakasipu kicked asking his son whether Lord Vishnu was imminent in a pillar too, was the same pillar. Lord Vishnu finally emerged as Ugra Narasimha, and killed the demon. **(360 Kms) from Amaravati.**

ARAKU VALLEY : The Araku Valley is a picturesque valley, about 160 Kms from Visakhapatnam. It is reached by a good road which climbs up the Anantagiri Ghat (mountain) to 1,116 metres after which it descends to the valley which is itself about 975 metres above sea level. There is a good deal of colonisation here, and a project to develop the valley is well under way. The tribal people of the valley have their own folklore and traditions. The Dhimsa dance is peculiar to them.

About 85 km from here is the Machkund Hydro-Electric Project, a joint venture of the Andhra Pradesh and Orissa states. It has been constructed by harnessing the 168 metres Duduma waterfalls. **(439 Kms) from Amaravati.**

DRAKSHARAMAM : Draksharamam or Garden of Daksha contains a big Lingam of Shri Bheemeswaraswamy, about 6 metres height, stated to have been created by the seven mouths of Godavari, the sacred bathing ghat in this temple which confers in a condensed form all the sanctity obtained by separate baths in each of the seven rivers.

Noted not only for its architectural beauty and historical importance, but also for its sanctity and holiness, the temple attracts pilgrims in thousands every year. It can be reached from Kakinada and Rajahmundry by road. **(207 Kms) from Amaravati.**

HORSLEY HILLS : The climate of Horsley Hills, 1265 meters high, is delightful. The hills exude charm and generate an atmosphere of peace. The wooded slopes studded with groves of teak, red sandalwood, eucalyptus, gulmohar and mango, present a pleasing sight. It is a summer resort with accommodation for tourists. It is 165 km from Bangalore and 144 Km from Tirupati and both are air-linked. **(519 Kms) from Amaravati.**

KOLLERU LAKE : The big sweet water lake 'Kolleru' is a place made enchanting by legend and immortalized by history. It is the home of different varieties of fish and birds. About 8 km off the shore of the Kolleru lake in the West Godavari District is situated the Kolleru pelicary, which shifts according to the places selected by the pelicans for nesting. The birds migrate there around in September from district lands.

(83 Kms) from Amaravati.

KUCHIPUDI : Kuchipudi the birth place of a famous dance form was founded by Siddhendra Yogi. The Siddhendra Kalakshetra at Kuchipudi offers a five year course conferring the qualification of "Natayacharya". It is a must for a cultural tourist. **(51 Kms) from Amaravati.**

LEPAKSHI : What enchanting memories it revives! dedicated to Lord Siva in Vijayanagar style stands facing God Vishnu's shrine. Hanging tower supported from above is a wonder. Under it can pass a piece of cloth. The huge monolithic Nandi at Lepakshi is the largest of its kind.

(570Kms) from Amaravati.

MAHANANDI : Mahasivaratri is celebrated here, when thousands of pilgrims congregate to worship Sri Mahanandeswaraswamy. It is not only a place of pilgrimage but also a picnic spot in view of the natural scenery in which the temple is set in the Nallamalai Hills. **(352 Kms) from Amaravati.**

MANTRALAYAM : Mantralayam Road Railway stn. Is 15 Kms from the shrine of Sri Raghavendra Swamy Temple, which is situated on the banks of Tungabhadra river. Devotees believe that the shrine has curative and miraculous powers. Annual festival is held in August. Mantralayam temple is in Kurnool District. **(440 Kms) from Amaravati.**

NAGARJUNAKONDA : The importance of the great modern temple is enhanced because amidst the beautiful sheet of water stands a tiny island "Nagarjuna Konda" which houses a unique museum with Buddhist relics.

PUSHPAGIRI : Pushpagiri meaning the Hill of flowers is sacred to both devotees of Vishnu and Shiva. There are eight temples on the hill including one dedicated to Kasi Viswanatha. A Chola King has built them for averting evil effects. It is in Kadapa District.

RYALI : When a person was going in a boat on Godavari, 1.25 Km from this place, he heard bhajans from a dense and uninhabited forest, so goes the legend. He walked in the direction of the sound into the

forest where he found a stone idol and heard a mysterious voice directing him to take the idol on the boat till the boat voluntarily stopped, and then on car till its wheeling slipped down. The voice directed him to install the idol at that place. The spot where the pin fell down came to be known as Ryali.

Jaganmohini Chennakesavaswami temple at Ryali, is a unique attraction to pilgrims, with a male face in front as Chennakesava and a female face in the back as Jaganmohini. Goddess Ganga is at the foot of the idol. This is reputed to be the only sculpture of its kind in India. One can reach this temple from Vijayawada which is air-linked. **(170 Kms) from Amaravati.**

SIMHACHALAM : As a pilgrim center Simhachalam ranks with Benaras and Tirupati. This hill temple is dedicated to Narasimha, the lion aspect of Vishnu. The main deity is always covered with "Chandanam" (sandal paste) and only on Chandana Yatra day, the people can have darshan of the Lord in his real form. The important festivals are Chandanayatra, Kalynam festivals and vyasapurnima and they occur generally in April and May every year. **(650 Kms) from Hyderabad**

SRI KALAHASTI : 36 Kms from Tirupati is the sacred shrine of Vayu the wind God at Kalahasti town. Vayu aspect of Lord Siva is worshipped here as Kalhasthiswara swamy. Legend has it that the Linga here was worshipped by a spider (Sri), a snake (Kala) and an elephant (Hasti) and hence the town came to be known as Sri Kalahasti. **(380 Kms) from Amaravati.**

SRIMUKHALINGAM TEMPLE : Situated on the bank of Vamsadhara river, it is said that this temple was installed by the Eastern Ganga King of Kalinga. A study of the architecture of the temple reveals interesting stories of Ramayana and Mahabharat.

SRISAILAM: Bhramarambe Mallikarjunaswamy of Srisailam is a very sacred shrine of all India importance, the presiding deity Sri Mallikarjunaswamy being one of the twelve Jyothirlingams in India.

Here is a great Sakti Peetha of the Goddess Bhramaramba in the form of Kali which is said to be one of the eighteen leading Saktis of India.

There are innumerable legends relating to Goddess Bhramaramba. The most widely current legend is that Goddess Durga took the form of a bee in order to put an end to Mahishasura and after his death the whole earth except Srisailam was drenched with his blood and so Goddess Durga made this holy spot her permanent abode. According to another legend, Goddess Durga, while fighting this demon, wore a garland of lotus flowers with bees in them and hence she is named Bhramarika or Bhramaramba. It is said that the great Shivaji worshipped the Goddess Sri Bhramaramba here and he achieved glory with her blessings.

The temple is on the top of a hill, 457.2 meters above sea level in the midst of rich natural scenery in the Nallamalai forests. Here River Krishna flows elegantly like a quiet serpent, a beautiful sight to behold. **(270 Kms) from Amaravati.**

TIRUPATI : The universally known temple of Lord Sri Venkateswara situated at Tirupati, is known as Balaji in the North and Srinivasa Perumal in the extreme South. Tirumala has seven hills and hence the God is called "Edukondalavadu" the God of seven hills. The idol has the attributes of both Vishnu and Shiva. The glory and greatness of the Lord makes every day a festival day with thousands of pilgrim tourists attracted there from all parts of the country. The Tirumala shrine is a masterpiece of Dravidian architecture, with an exquisitely carved gopuram facing east. The Vimana is completely covered with gold plate and is known as Anandanilaya.

Sri Venkateswara temple is one of the most ancient and also the richest Vaishnavite shrines in India. Lord Venkateswara in this great temple Internetlex is called Balaji in the north and Srinivas perumal in the South.

Every day is a festive day here. Shops remain open day and night, selling camphor and offering of hair by the devotees to Lord Venkateswara.

Sri Govinda Raja Swamy temple, Kapila teertham at Tirupati, Papanasanam, Akasaganga, Varahaswamy temple at Tirumala are all sacred. **(360 Kms) from Amaravati.**

VISHAKHAPATNAM BEACHES : The beaches of Vishakhapatnam have special attraction for swimmers and sun bathers. Lawson's Bay near Walter is lovely and shallow and best suited for swimming and bathing. A 24 km road along the beach from Vishakhapatnam to Bheemunipatnam offers a fine drive. **(420 Kms) from Amaravati.**
