Quotations in sealed covers are invited from the authorized dealers/local agencies for awarding Non-Comprehensive Annual Maintenance Contract of two (2) numbers of 1250 KVA Diesel Generator sets of Supernova make (Engine-Perkins & Alternator-Leroysometetc) installed in the High Court, Nelapadu, in the year 2019, for upkeep of the said equipment including – B check activities, attending to regular servicing, replacement of oil filters, fuel filters, pre filters, air filters, engine oil, extended life coolant etc., equipment break down, engineering services, including periodical cleaning of the diesel tanks, labour charges etc. The contract period will be for a period of one year from the date of entering into contract, which may be extended at the option of the High Court.

Activities to be carried out by successful bidder includes

- 1. To Check & Correct (if any) Functionality of Controller, Gauges, Charging Alternator & Other Electrical equipment, Alternator Power Cables, Control Cable, Engine Electrical Systems etc.
- 2. To inspect Fuel System for: Leakage, Water Sediment, Piping Condition etc.

- 4. To carry out inspection of Diesel Generator set as per OEM-AMC Checklist.
- 5. M2 Maintenance To be done as a part of AMC visit when falls due.
- 6. To educate/ train the operating & maintenance staff on preventive maintenance.
- 7. To carry out minor repairs like arresting leakages, adjustments required etc., immediately, to ensure availability of Diesel Generator Set.
- 8. To plan and carry out visits as per mutually agreed schedule.
- 9. To inspect and carry out checks on Engine, Alternator and Control Panel as per check sheet during each monthly visit.
- 10. To guide & educate the operating staff of Customer on maintenance and operations.
- 11. To check the Log Book/records maintained by customer and guide accordingly.
- 12. To arrest the minor faults, leakages immediately.

- 13. To correct failures arising due to workmanship defects under the scope of contract
- 14. To attend Emergency/breakdown calls on priority and provide workable solutions, whenever feasible.
- 15. To adhere to safe working practice and take utmost care not to harm material and men around the Equipment.
- 16. To depute trained engineers/technicians from its network to carry out services.
- 17. To meet all statutory norms in terms of workmen involves in this contract.
- 18. Services offered under this contract will be in accordance with Engine & Alternator Manufacturer's standard services instruction/practices.
- 19. Ensure smooth operation of DG set (both Auto &Manual mode) from DG Synchronization Panel without any faults & alarms.
- 20. Measure & report any critical parameters like DB level, exhaust temperatures, fluid temperature & vibration levels if necessary.
- 21. Taking all pro-active and re-active steps to ensure DG Set protection installed in High Court of Andhra Pradesh.
- 22. Inspection and providing alerts to the High Court authority on all the required spares or consumables as required for



providing uninterrupted power supply by means of DG set and Synchronization panel etc., on pro-active basis and submitting quotations on cost-to-cost basis (if required).

- 23. Ensuring uninterrupted and stable flow of power supply to High Court building by means of DG Set and to take precautionary measures to fine-tune the same on cost-to-cost basis (if required) as per the instructions of High court authority.
- 24. Ensuring 100% end-to-end power supply infrastructure at all times by means of DG sets & Synchronization panels to Main LT Panel at Electrical Sub Station.
- 25. Taking the responsibility of 24*7 DG infrastructure availability 100% for the entire maintenance period. Also, to take the responsibility of ownership in every issue that is raised to OEM *(Original Equipment Manufacturer) for better co-ordination and speedy resolution.
- 26. Any other maintenance related task as entrusted by the High Court authority during maintenance period.
