4. Partial or incomplete quotations will not be accepted.


5. The quotations received after the time and date prescribed will not be considered.

7. The successful bidder should deliver the items so ordered in the Computer Section, High Court of A.P. Nelapadu, Amaravati at its/his/her own expenses.
8. The items supplied, if found to be inferior in quality, will be summarily be rejected.
9. The High Court will not be responsible for any damage of goods during the transport and damaged goods will not be accepted and payment will be made only to the goods that are received in good condition.
10. Payment will be made only after supply of Thermal Barcode Stationary items to the satisfaction of the High Court and no advance payment will be made.
