CORRIGENDUM**

All the prospective bidders are requested to note the corrigendum in Tender document towards Translation and Vetting works of Judgments pertaining to the Supreme Court of India and the High Court of Andhra Pradesh from English to Telugu, Extraction and Vetting of Head-Notes pertaining to the High Court of Andhra Pradesh:

Therefore all the intended bidders may go through the changes, modifications, additions as shown in the below and submit the tenders accordingly:

I. *Existing Provision: Under Part-V Qualification Criteria b(i) reads as below*

“The Bidder should be a profitable company (registered in accordance with law for all purposes including GST Taxes, etc.) for the last 3 years and must have an annual turnover of not less than Rs50.00 Lakh for each of the the last three financial years ending years 2025-2026.”

The clause to be modified may be Read as:

The bidder shall be a profit-making entity, duly incorporated/registered under applicable law, and compliant with GST, Income Tax, and other statutory requirements for the last three (3) financial years ending FY 2025-2026. The bidder must have achieved total 1.50 Cr turnover combining the said three(3) financial years.

For Proprietorship Firms the following Certificates are exempted

- a. Certificate of Incorporation from Registrar of Companies (**ROC**)
- b. Relevant sections of the Memorandum of Association of the company or filings with the stock exchange to indicate the nature of the business of the company.
