Terms & Conditions:

1. The bidder should have at least 2 (years) of experience in the sales, service and support.
2. The Registrar (IT-cum-CPC) may at his discretion to ask the bidder for clarification of their bids including price.
3. The bidder should enclose copies of valid registration of PAN & GST.
4. The bidder should have financial turnover of Rupees 10,00,000/- Lakhs or above for each financial years 2023-2024, 2024-2025 and 2025-26, a copy of the certificate to that effect should be enclosed along with quotation.
5. The Bidder should attend service or deploy service engineer(s) (including holidays) in case of any hardware and software repair(s) during the warranty period and after Warranty period (for three years) without call logging option and if necessary the bidder should log the call.
6. Supply and delivery should not be later than 3 (three) weeks from the date of issue of Purchase Order.
7. The successful bidder shall have to deliver the said Hardware and Software at the High Court of Andhra Pradesh at Nelapadu or at the places specified and shall obtain proper acknowledgment from the concerned and shall submit the installation report to the undersigned.

Quotation Submission

1. Quotations should be submitted in a sealed envelope cover in the name of Registrar (IT-cum-CPC), High Court of Andhra Pradesh.
2. The quotation must be with Unit Price inclusive of all charges, including service charges, and applicable taxes (GST or other).
3. Quoted prices should be valid for 60 days from the date of submission.
4. Partial or incomplete quotations will not be accepted.
5. The successful bidder will have to furnish unconditional Bank Guarantee @10% of the Purchase Order Value to the High Court of Andhra Pradesh, valid for Three years Two Months i.e., 38 Months, within 15 working days from the date of receipt of Purchase Order towards service guarantee, in the name of the Registrar (Administration), High Court of Andhra Pradesh.

Payment Terms:

1. After delivery of the complete quantity and testing of the supplied Hardware and Software, the payment will be paid through CFMS Government of Andhra Pradesh by deducting the TDS and other taxes if any, as per the rules etc.,
2. The Price shall be quoted in Indian rupees only and shall quote inclusive of all taxes as applicable.
3. The successful bidder shall demonstrate the model offered by them to the High Court well in advance for testing purpose before delivery of product as required.

Warranty:

1. Three (3) years comprehensive onsite warranty and support shall be extended by the bidder from the date of supply, including free provision of spare parts as and when necessary.
2. The warranty period begins from the date of satisfactory installation, commissioned and certified by the authorized officer of the High Court.
3. The Registrar (IT-cum-CPC), High Court of Andhra Pradesh reserves all rights to accept and reject the quotations without assigning any reason(s).

Rate Contract:

The cost finalized by APHC in tender will be used as Rate Contract for a period of Six (6) Months from the date of Purchase order. There will not be any price increase during the RC validity period. Further, in the event that the manufacturer releases any upgraded, revised, or latest version/model of the contracted product during the Rate Contract period, the successful bidder shall supply such latest version/model at the same rates and on the same terms and conditions as stipulated in the Rate Contract, without any additional financial implication to the High Court of Andhra Pradesh, provided that the upgraded version/model meets or exceeds the technical specifications and functionalities of the originally contracted product.

ARBITRATION:

If any dispute or difference of opinion arises between parties concerning the terms of agreement or their respective rights, responsibilities, or liabilities, then the parties shall meet and try to settle these amicably. If the parties fail to reach an amicable settlement within a reasonable time, the dispute, doubt or difference of opinion shall be referred to arbitration of a sole arbitrator to be

nominated by the HIGH COURT. The decision of the arbitrator shall be conclusive, final and binding on both the parties. The jurisdiction of the court will be in the State of Andhra Pradesh.

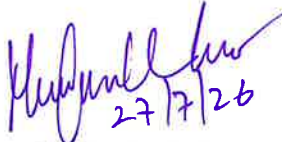
