Quotations in sealed covers are invited from the Local Agencies for supply of 74 Nos. of **7ft. Tables/Writing Desks**, with under storage shelf and foot support throughout the length of the Table, for use in the High Court of Andhra Pradesh at Amaravati. The Technical Specifications in detail are as follows:

Overall size	Length = 2134 mm/7 ft., Width = 610 mm/2 ft., Overall Height = 850 mm/2.8 ft. Working Height = 2.5 ft/30 inches and Front Privacy Panel Height = 305mm/1 ft. from the Table bottom and supporting Board/Sheet at the center.
Under shelf (W:7" x H:10")	Each 7 ft. Table shall be equipped with horizontal shelf throughout the length of the Table.
Foot support	Throughout the length of the Table at a height of 101.6 mm or 4 inches from Table bottom.
Material	The Table, Shelf and all other parts shall be made using 36 mm Boilo Board (High density boiling water proof and fire retardant engineered Action Tesa Boilo Board/Sheet).
Front elevation	Each Table must have an elevation (2134mmx50.8mm) throughout the length of the Table to prevent Books/Case Files from slipping off.
Finish and Appearance	Finished with Premium PU high-gloss polish in Cherry Teak shade, or any other shade as directed by the High Court and uniform wood grain finish with premium craftsmanship for an elegant appearance.
Edges	Smooth, rounded edges provided for safety and aesthetic appeal. Edges beading shall be of teak wood.
Internal supports	Strong internal partition supports provided for enhanced durability.

The intending Bidders shall visit the High Court of Andhra Pradesh, Nelapadu, Amaravati, and inspect the sample Table/Writing Desk available therein before submitting their quotations. They may contact/visit the Stores Section (0863-2372733) between 10:30 a.m. and 5:30 p.m., on all working days for any further queries.

The successful Bidder shall produce a sample of the Tables/Writing Desks (7 ft. length) as per the above specifications and the sample Table available at the High Court of A.P., before supplying the remaining Tables and the colour of the Polish must be changed as per the directions the High Court, if necessary.

The successful Bidder shall undertake repair or polishing works of the Tables/Writing Desks supplied, at its own cost, for a period of three (3) years from the date of delivery.

The successful Bidder shall deposit 5% of the total value of the order as Security Deposit, which shall be refunded after completion of the aforesaid period of three (3) years, subject to satisfactory compliance with the terms and conditions.

The intending Bidders shall submit their sealed quotations, clearly indicating the basic price, taxes and any other applicable charges separately, along with all necessary information and details of their track record, if any. The sealed cover shall be superscribed **"Quotation for Supply of 7 ft. Tables/Writing Desks"** and submitted during office hours, i.e., from 10:30 a.m. to 5:30 p.m., on or before **15.09.2026**, at the Office of the undersigned in the 2nd Floor, High Court Buildings, Nelapadu, Amaravati.

The quantity of Tables/Writing Desks may be increased or decreased as per the requirement.
