Quotations in sealed covers are invited from the Local Agencies for supply of 116 Heavy-Duty Three Seater Stainless Steel Sofas, for use in the High Court of Andhra Pradesh at Amaravati. The technical specifications in detail are as follows:

Particulars	Technical Specifications
Overall sizes	Length about 1,725 mm (5feet 8inches), Seat Height: 440mm (1foot 5.3inches), Back rest height: 610mm (2feet), Individual seat width: 500mm (1foot 7.7inches), Legs/frame pipe diameter: 38 mm (1 ½ inches) and Overall weight about 30Kgs.
Material	The complete sofa shall be manufactured from SS 304 Grade stainless steel of good quality and suitable for heavy-duty institutional use.
Main Frame	Main frame shall be made of 38 mm diameter SS 304 stainless steel pipes, providing adequate strength and stability.
Arm rests	Four (04) arm rests shall be provided and shall be made of 38 mm diameter SS 304 Grade stainless steel pipes.
Base Bushes	The legs/frame shall be fitted with virgin nylon/PP base bushes to provide stability, protect the flooring and prevent direct contact of the metal frame with the floor.
Seat Shell	Seats shall have an ergonomically curved, single-moulded "L"-type shell, manufactured from 1.1 mm thick SS 304 Grade stainless steel sheet.
Back rest Perforations	The back rest shall be provided with laser-cut, burr-free circular-shaped perforations, with smooth and uniform finishing.
Back rest Reinforcement	The back rest shall be internally reinforced with 18 mm diameter, 1.2 mm thick SS 304 Grade stainless steel round pipes for enhanced strength and durability.
Finish	All exposed stainless steel surfaces shall have a smooth, uniform and high-quality finish, free from sharp edges, burrs, dents, scratches or other manufacturing defects.

The intending Bidders shall visit the High Court of Andhra Pradesh, Nelapadu, Amaravati, and inspect the sample Three-seater Stainless Steel Sofa available therein before submitting their quotations. They may contact/visit the Stores Section (0863-2372733) between 10:30 a.m. and 5:30 p.m., on all working days for any further queries.

The successful Bidder shall produce a sample of the Three-seater Stainless Steel Sofa as per the above specifications and the sample available at the High Court of A.P., before supplying the remaining Three-seater Stainless Steel Sofas. After finalization, Sofas shall be delivered in the High Court Buildings.

The successful Bidder shall undertake repair/replacement of defective parts or rectification of manufacturing defects, at its own cost, for a period of three (3) years from the date of delivery, subject to the terms and conditions prescribed by the High Court.

The successful Bidder shall deposit 5% of the total value of the order as Security Deposit, which shall be refunded after completion of the aforesaid period of three (3) years, subject to satisfactory compliance with the terms and conditions.

The intending Bidders shall submit their sealed quotations, clearly indicating the basic price per sofa, applicable GST/taxes and any other applicable charges separately, along with all necessary information and details of their track record, if any. The sealed cover shall be superscribed **"QUOTATION FOR SUPPLY OF HEAVY-DUTY THREE-SEATER STAINLESS STEEL SOFAS"** and submitted during office hours, i.e., from 10:30 a.m. to 5:30 p.m., on or before **25.09.2026**, at the Office of the undersigned in the 2nd Floor, High Court Buildings, Nelapadu, Amaravati.

The quantity of Three-Seater Stainless Steel Sofas may be increased or decreased as per the requirement.

The High Court reserves the right to accept or reject any or all the quotations without assigning any reason.
