ORDER:-

In the letter 5th read above, the Registrar General, High Court of Judicature, Hyderabad has stated that as per Rule 3 of the Andhra Pradesh State Judicial (Service & Cadre) Rules, 2007, and as amended in G.O.Ms.No.60 and 108, Law (LA&J-SC-F) Dept., dt.19.04.2010 and 06.08.2010 respectively with regard to Selection Grade Scale and Super Time Scale of District Judges is as follows:

"provided that among the category of District Judges, 25% of the cadre strength thereof who have put in not less than five years of service shall be classified as "Selection Grade District Judges" and 10% of the cadre who have put in not less than three years of service as Selection Grade District Judges' shall be classified as "Super Time Scale District Judges and it shall be deemed to have come into force w.e.f.01.01.2007"

and as per rule 4(2) of Andhra Pradesh State Judicial (Service & Cadre) Rules, 2007, the appointment to the class of Super Time Scale District Judges shall be by promotion on the basis of merit —cum- Seniority from among the cadre of Selection Grade Scale District Judges who have completed 3 years of Service.

2. The Registrar General, High Court of Judicature, Hyderabad has further stated that the High Court have decided to recommend the Government of Andhra Pradesh, for approval of the names of the following Selection Grade Scale District Judges who have completed 3 years of Service as Selection Grade Scale District Judges for appointment to Super Time Scale Grade District Judges from the dates shown below in the Column number (3) of the corresponding Table below:
